Eligibility Requirements

- Must be a resident of suburban Cook County.
- Household income must be at or below 200% of the Federal Poverty Level (FPL).
- Provide proof of identity, such as a valid government-issued photo ID.
- Limited to one-time assistance per family.
- Available for youth ages 5–18.

Families will work with program staff to access financial assistance for summer camps and after-school programs, ensuring youth have opportunities to learn and grow. This one-time assistance per family helps make extracurricular activities more accessible for children ages 5–18 in suburban Cook County, with staff available to provide additional support services if needed.
